ECBG DAISEY Report Guide

Risk Factors Report

Purpose of This Report

The Risk Factors Report provides a breakdown of all active children within the selected date range by whether they meet the criteria for the following risk factors:

- * Free & Reduced Lunch
- * Language
- * Developmental Risk
- * Foster or Kinship Care
- * Caregiver Education
- * Teen Parents

Additionally, the report provides a count of all active children by number of risk factors that they have. Data from the following forms is used in this report:

- * Caregiver Profile
- * Child Profile
- * Demographics and Risk Factors Form
- * ASQ-3

Who is counted in this report:

This report will count data from the forms listed above if:

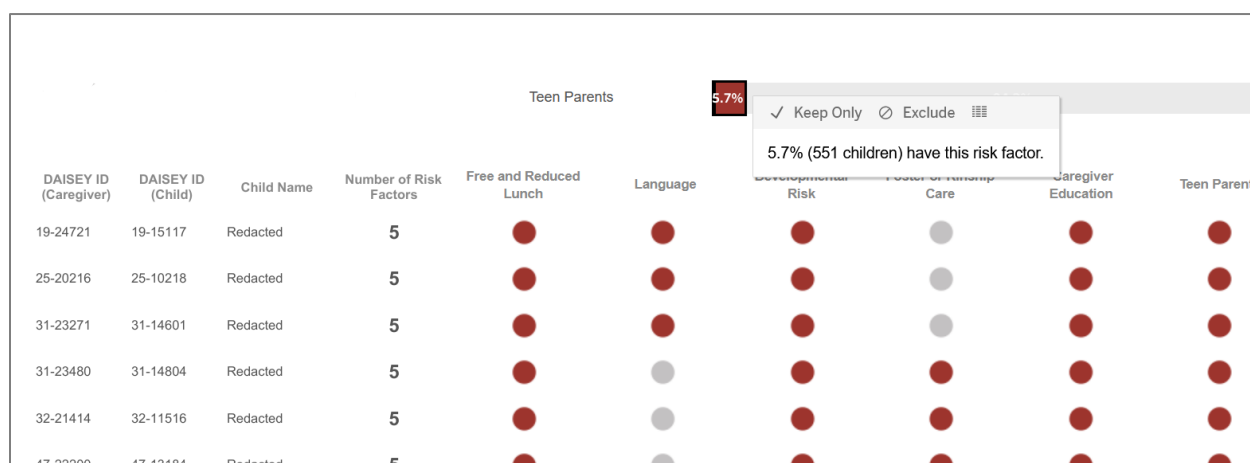
- * The child profile shows that it is 'enrolled' during the date range, meaning:
 - The profile has an enrollment date that is prior to the End Date selected on the report, and
 - The profile either does not have a discharge date, or the discharge date is after the Start Date selected on the report
- * There is form data with a Date of Activity within the selected date range for the forms listed above

The counts found in these reports are *unduplicated*, meaning each DAISEY profile will only be counted once in the report for the selected date range. Note that a child may still be counted as having multiple risk factors.

Using the child list in this report:

The report also includes a table listing each ‘enrolled’ (as defined in “Who Is Counted in this Report” above) child and an indication of how many risk factors they have, and which. The table will default to showing all ‘enrolled’ children in the selected date range, but selecting a segment from any of the risk factors bars will filter the table to show only children counted in that segment (see figure 1):

Figure 1: Selecting the segment of children with the Teen Parents risk factors updates the child table to show only the children with that risk factor



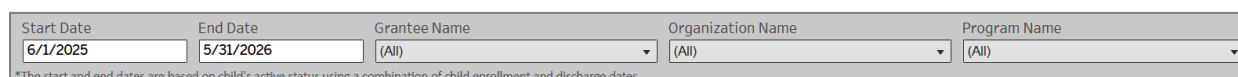

Filters used in this report

The Caregiver and Child Demographics reports utilize the following filters to allow users to modify the data displayed on the reports (see figure 2):

- ✱ Start and End Date: This will limit data displayed in the report to only show profiles who are ‘enrolled’ in the date range
- ✱ Grantee Name, Organization Name, and Program Name: This is for users with access to more than one Grantee, Organization, or Program in DAISEY to allow them to filter down to the specific data they wish to see

*The start and end dates are based on child's active status using a combination of child enrollment and discharge dates.

How this report calculates each Risk Factor

The report uses the following data to calculate whether ‘enrolled’ children have the identified risk factor:

Free & Reduced Lunch:

Uses data from the “Total Yearly Household Income Range” question on the Demographics and Risk Factors Form. The median value of the child’s selected household income range is used with the household size to determine if the household meets the criteria for free or reduced lunch. *Note: this differs from the annual evaluation of household income, which uses the minimum value of the indicated household income range.*

Language:

Uses data from the “What language does the primary caregiver speak/use the most with the child?” question on the Demographics and Risk Factors Form. Children indicating a language spoken by their primary caregiver that is not English are counted with this risk factor.

Developmental Risk:

Uses:

- ✱ Data from the “Does the child have an Individualized Family Service Plan (IFSP) or an Individualized Education Plan (IEP)?” and “Is this child participating in Part B (Assistance for Education of All Children with Disabilities) or Part C (Early Intervention) services?” questions on the Demographics and Risk Factors Form. Indications of ‘yes’ to either question are counted with this risk factor.
- ✱ Data from the ASQ-3 form – whether the child has an indicated delay in any of the subscales. Any indicated delay is counted with this risk factor.

Foster or Kinship Care:

Uses data from the “Is the child living in foster care, custodial kinship care...” question on the Demographics and Risk Factors Form. A response of ‘Yes’ is counted with this risk factor.

Caregiver Education:

Uses data from the “Primary Caregiver's Education Level” and “Secondary Caregiver's Education Level” questions on the Demographics and Risk Factors Form. Indications of < High School Diploma,

current High School enrollment, or High School aged but not enrolled are counted with this risk factor.

Teen Parents:

Uses data from the “Date of Birth” fields on both the Caregiver and Child Profile forms. If either parent indicates being <20 years of age at the time of the child’s birth, the child is counted with this risk factor.
